## Man injured after two Adams Run shootings

**NORTH CHARLESTON, S.C.** – Detectives continue to investigate two shooting incidents Sunday in the Adams Run area that are believed to be related.

Charleston County Sheriff's Office deputies responded before 1:30 p.m. to the 5300 block of Jupiter Hill Road, where witnesses reported that someone in a car had opened fire before driving away. The gunfire struck a home on Jupiter Hill Road and another on TJ Boulevard. Both homes were occupied, but no one was injured.

As deputies investigated the drive-by shooting, they received a report of the second incident about 2:30 p.m. In that case, the victim reported that he was riding in a car on Highway 174 near Highway 164 when he heard gunshots and was struck in the leg with a bullet. The victim told detectives that he had been at the location of the initial gunfire on Jupiter Hill Road before getting a ride with a friend, whose car was shot at. The man was taken to MUSC for treatment of non-life-threatening injuries.

It remains unknown whether the same shooter or shooters was involved in both incidents. Deputies did not immediately make any arrests.

struck by gunfire during the shooting, and each home was occupied. People also were outside the homes at the time.

Detectives are still investigating to determine whether the same suspect was involved in the second shooting on Highway 174.
